ORDER

As per the Government Order read as 2nd paper above, in principle sanction was accorded for the negotiated purchase of 13.3048 hectares of land at Puthussery West Village in Palakkad Taluk of Palakkad District, for developing it as Sanitary Land Fill under Kerala Solid Waste Management Project (KSWMP).

(2) The Deputy Project Director, KSWMP, as per letter read as 4 th paper above, reported that the total extent of the land is 12.5003 hectares instead of 13.3048 hectares and in view of the change in the extent of

land it is requested to issue revised Administrative Sanction for the purchase of the land and to entrust the District Collector, Palakkad to complete the process and procedures for the negotiated purchase.

- (3) Government have examined the matter in detail and are pleased to revise the Administrative Sanction, issued as per the GO read as 2nd paper above, with following conditions;
 - The extent of the land is 12.5003 hectares instead of 13.3048 hectares, at Pudussery West Village, Palakkad District.
 - The list of survey numbers and the extent of land under each survey number is enclosed herewith as Annexure.
 - The District Collector, Palakkad is entrusted to complete the further process and procedures for the negotiated purchase of the land as per the procedures established under the Circular read as 1st and the Government Order read as 3rd papers above.
- (4) The Government Order read as 2nd paper above stands modified to the above extent.
