## Tender Document for Selection of Non-Project Management Consultant

#### **Invitation for Tender**

The Executive Director, Suchitwa Mission, invites tenders from government-accredited agencies accredited for Non-PMC building work for the selection of a Non-Project Management Consultant agency for the Development of an Office facility including modification of the existing building, interior works, furnishing, electrification, and air conditioning to facilitate functioning of the Suchitwa Mission, Information Kerala Mission, and Clean Kerala Company Ltd.

### Scope of Work

The selected **Non-Project Management Consultant** will be responsible for overseeing and managing the following tasks:

### 1. Preparation of Architectural Layout of Office Space:

- Design and propose the office layout based on the requirements of the three entities (Suchitwa Mission, Information Kerala Mission, and Clean Kerala Company Ltd.)
- Provide professional recommendations for optimizing office space.

# 2. Conduct Discussions and Obtain Inter-Agency Approval for the Tentative Layout:

- Facilitate discussions among the three entities to finalize the tentative architectural layout.
- Obtain approval from each entity and ensure consensus for proceeding with the design.

# 3. Preparation of Detailed Drawings, Detailed Project Report (DPR), and Obtain Technical Sanction (TS):

- Prepare detailed architectural drawings for the project, including floor plans, elevations, and electrical/air conditioning layouts.
- Develop a Detailed Project Report (DPR) to outline the project scope, budget, and timelines.
- Ensure the preparation of the Technical Sanction (TS) from relevant authorities.

### 4. Construction & Development:

• Undertake construction activities, installation of all items envisaged in approved DPR to the satisfaction of technical committee.

### 5. Submission of As-Built Drawings:

• Prepare and submit the final **as-built drawings** once the project is completed to the satisfaction of the client.
