Read 1 Letter No. SM/2515/2024-C3-part(1) dated 03/08/2025 from the Executive Director, Suchitwa Mission.

ORDER

The Executive Director, Suchitwa Mission, as per the letter read above, has submitted a proposal for the establishment of four Regional Sanitary Waste Incineration Facilities in the State, each with a capacity of 20 TPD, at Kottarakkara (Kollam), Moovattupuzha (Ernakulam), Kuttippuram (Malappuram) and Kadannappalli (Kannur). As per the proposal, 50 cents of land is earmarked at each site, and the facilities are to be implemented by the Clean Kerala Company Ltd. (CKCL) under a suitable Public-Private Partnership (PPP) model with technical support from Suchitwa Mission.

2. The proposal aims to address the gap in the current decentralized Sanitary Waste Management system, ensure centralized processing, improve economies of scale, and achieve better logistical efficiency.

3. Government have examined the matter in detail and are pleased to order the following:

i. In principle sanction is accorded for setting up four Regional Sanitary Waste Incineration Facilities of 20 TPD capacity each at the locations specified above.

ii. Clean Kerala Company Limited is authorised to initiate the tender process for the projects, with technical support from Suchitwa Mission.

iii. CKCL is directed to take possession of the earmarked land for each facility, following due procedure.

4. A dedicated Technical and Monitoring Committee is constituted to ensure timely implementation, transparent procurement and effective monitoring of the project, with the following composition as requested by Executive Director Suchitwa Mission :
