### **ORDER**

The Muttathara Sewage Treatment Plant (STP) in Thiruvananthapuram, which is designed to handle 107 million litres per day (MLD), is currently treating both municipal sewage and an additional load of 80–100 truckloads of septage daily through the Activated Sludge Process (ASP). The significant volume of sludge produced, over time, has resulted in critical space limitations within the facility. The ongoing on-site sludge disposal has led to the gradual loss of usable land, severely impacting operational efficiency and posing long-term sustainability concerns.

To tackle this challenge, the establishment of a dedicated Faecal Sludge Treatment Plant (FSTP) has been identified as a necessary intervention and as part of this initiative, the Omni-Processor (OP) technology licensed by M/s Ankur Scientific Energy Technologies Pvt. Ltd. is getting implemented with grant support. A formal Memorandum of Understanding (MoU) has already been executed with the technology provider.

The Omni-Processor (OP) system offers a high-efficiency approach, capable of reducing sludge volume by over 95% while simultaneously recovering valuable resources such as clean water, electricity, heat, and

pathogen-free ash. This approach supports Kerala's vision for sustainable development and waste-to-resource transformation. With the regulatory approvals currently in progress, the formation of a dedicated Project Monitoring Committee was proposed to ensure robust oversight of the Project for which the Suchitwa Mission has submitted detailed proposal, as per the letter read above.

Government examined the matter in detail and are pleased to constitute a Project Monitoring Committee, for the implementation of the Omni Processor at 107 MLD Muttathara Sewage Treatment Plant (STP) in Thiruvananthapuram, as follows;

1. Monitor on-ground implementation progress and adherence to timelines.
2. Ensure quality control in the commissioning and operationalization phases.
3. Oversee environmental and safety standards, particularly discharge quality and emissions.
4. Facilitate coordination between contractor/technology provider, KWA,

Corporation of Thiruvananthapuram, and Kerala State Pollution Control Board.

5. Document and report monthly progress to the Suchitwa Mission and Local Self Government Department.
